

## ICC and the General Assembly

ICC is an international Indigenous Peoples' Organization, founded in 1977 to strengthen unity among Inuit of Alaska, Canada, Kalaallit Nunaat, and Chukotka. ICC promotes Inuit rights and interests at the international level, develops and encourages long-term policies that safeguard the Arctic environment, and seeks full and effective participation and meaningful engagement in the political, economic, and social development of the Arctic region.

ICC holds Consultative Status II at the United Nations Economic and Social Council, is a co-founder and Permanent Participant at the Arctic Council, an Observer at the Intergovernmental Panel on Climate Change, and holds Permanent Consultative Status at the International Maritime Organization alongside other advisory and consultative roles across numerous international fora.

ICC holds a General Assembly every four years at which delegates from across the circumpolar region elect a new Chair and executive council, develop policies, and adopt resolutions that will guide the activities of the organization for the coming term. The General Assembly is the heart of the organization, providing an opportunity for sharing information, discussing common concerns, debating issues, celebrating our rich cultural heritage and strengthening the bonds between all Inuit. The ICC General Assembly is the largest gathering of Inuit across the globe.


In 2026, it is Canada's turn to host the General Assembly in Iqaluit, Nunavut, from July 22 – 25. Nunavut Tunngavik, Inc. (NTI) is the host 2026 General Assembly. NTI is responsible for the accommodations, meals, ground transportation, translation/interpretation, security, and other needs of the official delegation and participants from Alaska, Canada, Chukotka (Russia) and Greenland.



ICC Alaska is a member country to the Inuit Circumpolar Council (ICC) and represents Alaskan Inuit at this international forum. ICC Alaska is organized as a 501(c)3 non-profit corporation that exists as the united voice and collective spirit of Alaskan Inuit, to promote, protect and advance Inuit culture and society. The organization represents and advocates on behalf of the Iñupiat of the Arctic Slope, Northwest, and Bering Straits; St. Lawrence Island (Siberian) Yupik; and Central Yup'ik and Cup'ik of the Yukon-Kuskokwim Delta in Southwest Alaska. Member organizations include the North Slope Borough, Arctic Slope Regional Corporation, Inupiat Community of the Arctic Slope, Northwest Arctic Borough, NANA Regional Corporation, Maniilaq Association, Bering Straits Native Corporation, Kawerak, Incorporated, and Association of Village Council Presidents.

In addition to the international efforts, ICC Alaska also works on statewide and national issues. Priorities are set by the Board of Directors guided by the mandates given to the ICC at the General Assemblies.

During the last term, working towards the first priority to “Influence Systematic Change” in the organization’s strategic plan, ICC Alaska’s facilitated the development of the “Alaskan Inuit Arctic Strategy”: a bold and unified statement of the Arctic that Alaskan Inuit Want, defined and governed by Inuit and founded in Inuit cultural values, lived experiences, and Indigenous Knowledge. Inuit Led Development and Conservation; Climate Change Impacts on our Communities; Inuit-led Marine Governance; Inuit Food Security and Sovereignty; and Inuit Community Well-being were priorities identified in the Arctic Strategy.



## ICC General Assembly Agenda

The General Assembly takes place over the course of four days. Each day will be chaired by one of ICC's four member nations: Alaska, Canada, Chukotka, and Greenland.

## Financial Considerations

Each country delegation brings an official delegation of approximately 45-60 participants, including 18 delegates, cultural performers, staff, Inupiaq and Yup'ik interpreters, speakers and invited guests.

### **Alaskan Inuit Delegation Participation**

Alaskan Inuit participation in the Inuit Circumpolar Council (ICC) General Assembly is estimated to cost \$155,500 for travel to/from village/region to Iqaluit, Nunavut, Canada, coordination and planning and communications/media.

The total ICC Alaska General Assembly Budget is estimated at \$225,500. This includes an estimated \$70,000 contribution towards ICC Chukotka delegation's participation in the GA. This represents one-third of the average estimated cost which is to be shared by Alaska, Canada and Greenland (see more details below).

The host community, led by Nunavut Tunngavik, Inc., will provide local accommodations, meals, transportation, translation/interpretation equipment and other on the ground needs of the official delegation and participants from Chukotka (Russia), Greenland, Alaska and Canada.

### **Chukotkan (Russia) Delegation Participation**

A seat at the General Assembly was left vacant as a symbolic reminder that Inuit from Chukotka (Russia) had not yet been able to join the ICC. In 1992, Chukotkan Inuit delegates were officially in attendance in Inuvik. With limited fundraising opportunities in Chukotka, it is always a struggle to finance and bring a delegation of 15 to each General Assembly. ICC Alaska, ICC Canada and ICC Greenland work together to assist the Chukotkan delegation in fundraising to attend the General Assembly. The total budget for Chukotkan participation is estimated at \$70,000 Alaska, Canada and Greenland are working to each raise one third of the total budget. In addition to travel, interpretation services and translation of documents will be required for the Chukotkans to participate in the GA.

Major expenditures are anticipated related for ICC Alaska in the following areas:
